This is a course about early modern Spain. It will concentrate on two key periods, the 1500s and the period 1750-1820. It will emphasize social and economic developments and the link between Spain and her empire.

There will be NO examinations as such. Each student will undertake two writing projects. In both cases I will give you a short list of possible topics to choose from. If you want to develop an alternative, write a one-paragraph prospectus for what you would like to do and we will discuss it. Each paper counts 50% of the grade. You MUST make a good faith effort on BOTH papers to get a passing grade. Details will come in class.

1. The first paper will deal with the society and culture of Spain and its empire in the sixteenth century. Your sources will be the books by Kamen and Perry and the *Two Picaresque Novels*.
2. The second paper will focus on society, imperial revival, and Spain's version of the 18th-century's road to European modernity. Your main sources will be the book by Ringrose (me) and chapters 9 and 10 in Kamen.
