## The History of Women in Europe, 1870\_Present

This course will be a chronological and thematic survey of the history of women and gender in Europe since 1870. On the one hand, it will explore the changing context of women's lives over the course of the  $20^{\,\mathrm{th}}$  century, and how women negotiated the choices and constraints they were faced with. We will examine both the everyday reality for women of different social classes and races, and their participation in the broader social and political movements that defined the 20<sup>th</sup> century. In a century that witnessed dramatic changes in women's roles, we will look at these changes but also at the more subtle continuities. In order to frame a history of European women in this period, women's historians have long argued that it is important to both understand the household life that many women defined themselves through, and to recognize the often-hard-to-see roles they played in public life as well as the connections between these "private" and "public"lives. These connections will be made by asking how normative concepts of masculine and feminine-ie, gender-- affected broader historical processes, events and public policies.
